Financial Performance: Notes

- In Transport segment, execution is going on at very fast speed in all EPC Projects. Construction is going on in six HAM projects. Construction in Waranga Mahagaon section is expected to start soon. We have applied for PCoD in following projects and received completion certificate in DMRC CC-57:
- Yamunanagar Panchkula package II : Applied on 10.01.2018
- Eastern peripheral expressway package II: Applied on 02.01.2018
- DMRC CC-57: Completion certificate received on 30.11.2017 with completion date as 25.11.2017
- In irrigation segment, we have received completion certificate for the following projects during FY18 –
